(Mar 2014) - Southwark Council v BI - Inner London Crown Court - Prosecution counsel in POCA proceedings where Court found criminal lifestyle existed and a confiscation order was made for over £30,000.

(Jan 2013) R v JS - Aylesbury Crown Court - Junior counsel in a two-day hearing concerning confiscation of proceeds from breaches of planning legislation in relation to an illegal car park.

General and Serious Crime

Adele has been instructed to prosecute and defend across a broad range of offences.

Notable cases:

(May 2015) – R v J – Wolverhampton Crown Court – Defence counsel securing not guilty verdict in case concerning weapons charges.

(March 2015) - R v S- Wood Green Crown Court - Defence counsel in sexual assault case where defendant acquitted.

(Jan 2015) - R v AM - Wood Green Crown Court - Defence counsel for youth accused of robbery and firearm offences, where client was acquitted.

Extradition

Adele has been instructed to represent requested persons subject to European Arrest Warrants both at first instance at Westminster Magistrates' Court and on appeal. Adele is often instructed to advise in writing on grounds for appeal against extradition.
